ROBERT SCHMISSEUR, COUNTY COUNSELOR, GALE ROSE, PRATT TRIBUNE REPORTER AND SHERRY KRUSE, COUNTY CLERK, WERE ALSO PRESENT.

THE MEETING WAS OPENED WITH THE PLEDGE OF ALLEGIANCE.

SHERIFF WHITE TOLD THE COMMISSIONERS HE HAD NOTHING TO REPORT.

SCOTT HARRIS, EMERGENCY MEDICAL SERVICES DIRECTOR, DISCUSSED DEPARTMENT POLICIES; COMMISSIONER JONES MADE A MOTION TO ACCEPT THE CHANGES TO THE AMBULANCE DEPARTMENT POLICIES. COMMISSIONER BORHO SECONDED THE MOTION. MOTION CARRIED 3-0.

TIM BRANSCOM, EMERGENCY MANAGEMENT/ZONING ADMINISTRATOR, REPORTED THE PLANNING BOARD IS MEETING TONIGHT AT 7:00 P.M. AT THE COMMUNITY CENTER TO HEAR A CASE ON A CONTAINER STORAGE FACILITY AND RV STORAGE AT THE CORNER OF SE 30TH ST AND SE 30TH AVE; WILL BE IN WICHITA ON THURSDAY FOR A TABLE TOP EXERCISE; LEPC MEETING MOVED TO MARCH 7, 2019 11:00 A.M. TO 1:00 P.M. AT THE CITY FIRE BUILDING.
