

THE PRATT COUNTY COMMISSIONERS MET MONDAY, MARCH 20TH, 2017 AT 4:00 P.M. IN THE COMMISSION ROOM, COURTHOUSE, WITH THE FOLLOWING MEMBERS PRESENT: GLENNA L. BORHO AND JOE E REYNOLDS. ALSO PRESENT WERE ROBERT SCHMISSEUR, COUNTY COUNSELOR, GALE ROSE, PRATT TRIBUNE REPORTER AND LORI VOSS, DEPUTY COUNTY CLERK.

DOUG FREUND, ROAD AND BRIDGE DIRECTOR, WOULD LIKE TO UPDATE A FORK GRAPPLE TO A 78", COMMISSIONER REYNOLDS MADE A MOTION TO APPROVE THE PURCHASE OF THE 78" FORK GRAPPLE AT A COST OF \$2,794.80, COMMISSIONER BORHO SECONDED THE MOTION.
