

THE PRATT COUNTY COMMISSIONERS MET MONDAY, APRIL 3, 2017 AT 4:00 P.M. IN THE COMMISSION ROOM, COURTHOUSE, WITH THE FOLLOWING MEMBERS PRESENT: DAVID L. WARD AND JOE R. REYNOLDS. GLENNA L. BORHO AND ROBERT SCHMISSEUR, COUNTY COUNSELOR, WERE ABSENT. ALSO PRESENT WERE GALE ROSE, PRATT TRIBUNE REPORTER AND SHERRY KRUSE, COUNTY CLERK.

THE MEETING WAS OPENED WITH THE PLEDGE OF ALEGIANCE.

DOUG FREUND, ROAD AND BRIDGE DIRECTOR, SUBMITTED A RAISE FORM FOR APPROVAL.

JASON WINKEL, LANDFILL/RECYCLING MANAGER, REPORTED KDHE INSPECTIONS SHOWED NO DEFICIENCIES AT THE LANDFILL OR RECYCLING CENTER; WORKING TO RENEW THE HOUSEHOLD HAZARDOUS WASTE OPERATING PLAN; FIVE YEAR UPDATE AT THE LANDFILL AND RECYCLING CENTER ABOUT WHAT CAN BE DONE BETTER; WILL INVOLVE A PUBLIC HEARING; PLAN IS DUE IN NOVEMBER 2017; MUDDY CONDITIONS AT THE LANDFILL; CONCRETE CRUSHER STILL WORKING AND WILL BE HERE FOR ANOTHER MONTH; CITY OF PRATT CLEANUP WEEK SCHEDULED FOR MAY 8 – 13, 2017.

DOUG FREUND, ROAD AND BRIDGE DIRECTOR, PRESENTED A ROAD CROSSING PERMIT FOR STAN MCAHREN TO RUN AN ELECTRIC LINE FOR AN IRRIGATION SYSTEM BETWEEN 24-26-15 AND 19-26-14.

D J MCMURRY, COUNTY APPRAISER, SUBMITTED A RAISE FORM FOR APPROVAL.
