

THE PRATT COUNTY COMMISSIONERS MET TUESDAY, MAY 28, 2019 AT 4:00 P.M. IN THE COURTHOUSE COMMISSION ROOM WITH THE FOLLOWING MEMBERS PRESENT: JOE R. REYNOLDS AND GLENNA L. BORHO. COMMISSIONER THOMAS W. JONES III WAS ABSENT. ROBERT SCHMISSEUR, COUNTY COUNSELOR, GALE ROSE, PRATT TRIBUNE REPORTER AND SHERRY KRUSE, COUNTY CLERK WERE ALSO PRESENT.

THE MEETING WAS OPENED WITH THE PLEDGE OF ALLEGIANCE.

JASON WINKEL, LANDFILL/RECYCLING SUPERVISOR, REPORTED ON DISPOSAL WEEK; SOLID WASTE INTAKE WAS 120.43 TONS; 699 TIRES UNDER 20" WITHOUT RIM; 23 TIRES UNDER 20" WITH RIM; 493 CUSTOMERS FOR THE WEEK; NO CONCRETE THIS YEAR; NEED TO TALK WITH RUSS RAMBAT ABOUT THE TIRES THEY RECEIVED AND DOING SOMETHING DIFFERENT NEXT YEAR; RECYCLING SHIPPED OUT CARDBOARD; PRICES ARE STARTING TO GET LOWER; LOTS OF OIL AT RECYCLING CENTER AND THEY CAN ONLY KEEP 2000 GALLONS ON HAND; GIVING PAINT AWAY AT THIS TIME; NEED SOME DRY WEATHER TO COVER PIT; RECEIVED MORE HOUSEHOLD HAZARDOUS WASTE THAN EVER BEFORE DURING CLEAN UP WEEK; 500-800 CANS OF PAINT.

TIM BRANSCOM, EMERGENCY MANAGER/ZONING ADMINISTRATOR, REPORTED MAJOR WINDS FROM THE STORM SUNDAY NIGHT OVER 70+ MILES PER HOUR; TIM SHOWED THE COMMISSIONERS THE NEW DRONE; TIM WILL DO TRAINING ON-LINE; BATTERY LASTS 30 MINUTES AND WE HAVE 3 BATTERIES; SHERIFF WHITE EXPLAINED WHAT THE NEW ROBOT WILL DO; TIM REMINDED THE COMMISSIONERS HE WILL PRESENT TWO ZONING CASES ON JUNE 10, 2019.

CATHERINE ROHRER, SOUTH CENTRAL KANSAS COMMUNITY CORRECTIONS DIRECTOR, REPORTED AN ISO/INTAKE OFFICER HAS RESIGNED EFFECTIVE JUNE 28, 2019; WILL ADVERTISE FOR REPLACEMENT.

SHERIFF WHITE REPORTED HE SPENT 2 ½ HOURS WITH SHAWN HARDING, HMN ARCHITECTS, REVIEWING THE LEC AND WHAT WORK NEEDS TO BE DONE.

DARCIE VAN DER VYVER, HEALTH DIRECTOR, INFORMED THE COMMISSIONERS SHE AND CRYSTAL FREEMAN GAVE A ONE HOUR PRESENTATION TO THE CIRCLES PROGRAM; THEY EMPHAZIED THE FREE SERVICES AT THE HEALTH DEPARTMENT; RECEIVED LIMITED TDAP VACCINES FOR DISASTER VICTIMS AND WILL BE GIVEN FIRST COME FIRST SERVE; CREATING PREPAREDNESS BOOKS FOR EMPLOYEES; STARTING TO UPDATE POLICIES AND PROCEDURES FOR THE HEALTH DEPARTMENT.
