

THE PRATT COUNTY COMMISSIONERS MET MONDAY, JULY 31, 2017 AT 4:00 P.M. IN THE COMMISSION ROOM, COURTHOUSE, WITH THE FOLLOWING MEMBERS PRESENT: DAVID L. WARD, GLENNA L. BORHO AND JOE R. REYNOLDS. ALSO PRESENT WERE ROBERT SCHMISSEUR, COUNTY COUNSELOR, GALE ROSE, PRATT TRIBUNE REPORTER AND SHERRY KRUSE, COUNTY CLERK.

THE MEETING WAS OPENED WITH THE PLEDGE OF ALLEGIANCE.

JAMES WHITE, SHERIFF, REPORTED HE HAD SOME ISSUES WITH THE JAIL PROJECT BUT THOSE HAVE BEEN RESOLVED; ROBERT SCHMISSEUR, COUNTY COUNSELOR, REMINDED SHERIFF WHITE THAT FINAL CONTRACTS FOR THE PROJECT HAVE NOT BEEN APPROVED YET; SHERIFF WHITE SAID THEIR CASE LOAD IS HIGHER THAN THE PREVIOUS 10 YEARS.

TIM BRANSCOM, EMERGENCY PREPAREDNESS/ZONING ADMINISTRATOR, TOLD THE COMMISSIONERS ONLY ONE 3<sup>RD</sup> CLASS CITY SHOWED UP FOR THE ZONING MEETING LAST WEEK; ANOTHER MEETING HAS BEEN RE-SCHEDULED FOR AUGUST 21, 2017; TIM WILL CONTACT THE 3<sup>RD</sup> CLASS CITIES AGAIN; PICKED UP TRUCK LAST WEEK.

COMMISSIONER REYNOLDS MADE A MOTION TO APPROVE THE MINUTES OF THE JULY 24, 2017 MEETING. COMMISSIONER BORHO SECONDED THE MOTION. MOTION CARRIED 3-0.

DARCIE VAN DER VYVER, HEALTH DIRECTOR, DISCUSSED UP COMING MEETINGS; BUSY WITH BACK TO SCHOOL SCREENINGS; THEY DO BACK TO SCHOOL PHYSICALS BUT NOT SPORTS PHYSICALS; COMMISSIONER BORHO TOLD DARCIE THEY HAVE A PROGRAM "SEE TO LEARN" THAT PROVIDES FREE VISION SCREENING; GOING TO MEET WITH DR. CANNATA TO UPDATE ORDERS; INFORMED THE COMMISSIONERS SHE NEEDS TO CREATE A FAMILY PLANNING BOARD; LANDSCAPING BIDS ARE DUE AUGUST 14; REVIEWED TWO BIDS FOR CLEANING THE HEALTH DEPARTMENT; ROBERT SCHMISSEUR, COUNTY COUNSELOR, TOLD DARCIE IT NEEDS TO BE HANDLED AS AN INDEPENDENT CONTRACTOR ON A MONTH TO MONTH BASIS AND A HIPPA FORM SIGNED; COMMISSIONER BORHO MADE A MOTION TO HIRE JAN BERRY FOR \$400 PER MONTH TO CLEAN TWICE A WEEK AT THE HEALTH DEPARTMENT. COMMISSIONER REYNOLDS SECONDED THE MOTION. MOTION CARRIED 3-0.

DALTON GLASSCOCK, FIELD REPRESENTATIVE/CONSTITUENT SERVICES FOR CONGRESSMENT RON ESTES' OFFICE, INTRODUCED HIMSELF TO THE COMMISSIONERS AND SAID HE HANDLES MILITARY AND VETERAN AFFAIRS; HE COVERS THE 4<sup>TH</sup> DISTRICT WHICH IS 17 COUNTIES; CONGRESSMAN ESTES WILL BE VISITING EACH COUNTY DURING THE AUGUST RECESS AND WILL BE IN PRATT IN LATE AUGUST; CONGRESSMAN ESTES IS ON THE HOMELAND SECURITY COMMITTEE AND EDUCATION IN THE WORKFORCE COMMITTEE; THE OFFICE IN WICHITA IS ON ROCK ROAD AND KELLOGG.

ROBERT SCHMISSEUR, COUNTY COUNSELOR, DISCUSSED THE AGREEMENT WITH HORIZONS MENTAL HEALTH FOR IMPLEMENTATION OF MENTAL HEALTH EVALUATIONS; REPORTED HIS MEETING WITH THE CITY ATTORNEY, REGINA GOFF, WAS ABOUT AS PRODUCTIVE AS THE MEETING LAST WEEK; ASKED FOR A FIVE MINUTE EXECUTIVE SESSION FOR ATTORNEY/CLIENT PRIVILEGE; COMMISSIONER BORHO MADE A MOTION AT 4:48 P.M. TO ADJOURN INTO EXECUTIVE SESSION FOR FIVE MINUTES FOR ATTORNEY/CLIENT PRIVILEGE. COMMISSIONER REYNOLDS SECONDED THE MOTION. MOTION CARRIED 3-0. COMMISSIONER BORHO MADE A MOTION AT 5:03 P.M. TO RETURN FROM EXECUTIVE SESSION WITH NOTHING TO REPORT. COMMISSIONER REYNOLDS SECONDED THE MOTION. MOTION CARRIED 3-0.

D J MCMURRY, COUNTY APPRAISER, DISCUSSED THE NEIGHBORHOOD REVITALIZATION PROGRAM.
